1) Opening:

- e) <u>Delegates</u>: <u>Delegate #1</u>: Sue H. Sue will attend the OA World Service Business Conference at the end of April/early May as our GSI delegate. She is happy to come to OA meetings to talk about OA governance, her delegate experience, etc.

7) Committee Reports:

- a) Standing Committees
 - 1. Events: Mary L
 - a) <u>OA Unity Day</u> Rachel. 32 people attended. The event realized a profit of \$105.75. All speakers were recorded. The Lake City library does not charge a room rental fee and there is plenty of parking.
 - b) <u>Winter Retreat</u> Mary gave a recap of the event: There were <u>sixty</u> overnighters and 40 commuters attending the winter retreat at Camp Brotherhood; it was a capacity crowd. Evaluations were received from 20 people. The following were key takeaways from the evaluations:

1. GSI was asked to make OA events more gender-neutral. It was suggested that GSI add a gentleman to the retreat planning committee.

2. Speaker recording: A Committee was formed to address the issue of posting a speaker recording with tradition violations and determined that GSI would not post the recording to seattleoa.org. Mary L. asks reps to contact her with event speaker recommendations. For future GSI events, speaker guidelines will be provided. It was also confirmed that there should have been no selling of outside literature at the retreat.

3. Mary also reported that some "Together We Can" t-shirts were sold; but there are several left over. Mary suggested that they can be sold on the GSI website: seattleoa.org.

- c) <u>HOW retreat</u> flyers for the HOW retreat at Camp Huston May 29, 30 and 31 are available for pick up. There is a planning meeting Sunday, March 8th, at 4 pm at St. Paul's. Beth G. is the retreat chair.
- d) <u>Spring marathon at the Saturday University meeting</u>: Planning is underway for an event at the Saturday morning University meeting with a "renewal" theme. The meeting will work closely with GSI to pick a date that doesn't conflict with other events.
- e) <u>Northgate</u> Tuesday meeting Mark A. stated that this meeting would like to host an event, perhaps in May, with May 12 or May 19 suggested as possibilities. Mark was encouraged to move forward with planning and stay in touch with GSI about dates. Mary L. mentioned that a key event planning parameter is the number of times the event can be advertised at GSI meetings and flyers distributed to GSI representatives. A GSI event master calendar on seattleoa.org is a future goal.

- 4. Audit volunteers and time Barbara, Stacey, and Jeri K. and Adele will arrange to meet. There was general consent that Jeri would be added to this committee also.
